STATUTORY RULES AND ORDERS NO. 8 OF 2003

IN EXERCISE OF THE POWERS CONFERRED BY SECTION 73 OF THE TELECOMMUNICATIONS ACT, 2000 (No. 31 OF 2000) THE MINISTER MAKES THE FOLLOWING REGULATIONS—

(Gazetted 4th April, 2003).

**1. Citation:** These Regulations may be cited as the

TELECOMMUNICATIONS (FEE STRUCTURE AND COLLECTION  
MECHANISM) REGULATIONS, 2003.

**2. Interpretation:** (a) In these Regulations “Act” means the Telecommunications Act No: 31 of 2000.

(b) Adjusted Gross Annual Revenue means information regarding the Gross Revenue for the reporting year received by, or due to the Licensee and its affiliates, from whatever source derived before any deductions from expenses, discounts, returns, or offsets of any kind, save and except domestic interconnection payments and those pass through taxes and/or charges collected for and on behalf of the Government.

**3. Commencement:** These Regulations shall be deemed to have come into effect on the 12th October 2001.

**4. Individual Licence:** (1) A person applying under the Act for an Individual Licence will be required to pay:

(a) the appropriate application fee as set out in Schedule 1; and

(b) on grant of the license the appropriate initial fee set out under the heading “License Fees” in Schedule 1; and

- (c) on or before each anniversary date of the granting of the license, and throughout the duration of the license the appropriate annual fee set out under the heading "License Fee" in Schedule 1.

**5. Class License:** (1) A person applying under the Act for a Class License will be required to pay:

- (a) the appropriate application fee as set out in Schedule 2; and
- (b) on grant of a Type A Class License the appropriate initial fee set out under the heading "License Fees" in Schedule 2; and
- (c) on or before each anniversary date of the granting of the license and throughout the duration of the licenses the appropriate annual fee set out under "License Fees" in Schedule 2.

**6. Frequency Authorization:** (1) A person applying under the Act for a Frequency Authorization will be required to pay:

- (a) the appropriate application fee as set out in Schedule 3 under the heading "Spectrum Fees", sub-heading "Application".
- (b) on the grant of a Frequency Authorization, and on or before each anniversary date of the granting of the Frequency Authorization, the appropriate annual fee as set out in Schedule 3 under the heading "Spectrum Fees", sub-heading "Annual".

**7. Special License:** (1) A person applying under the Act for a Special License will be required to pay the appropriate fees as set out in Schedule 4.

**8. Payment of Fees:** (1) A person paying fees in accordance with Regulations 4, 5, 6 and 7 of these regulations will make payment to the National Telecommunications Regulatory Commission by bank draft or other monetary instrument and in such form as directed by the National Telecommunications Regulatory Commission.
