1. The National Telecommunications Regulatory Commission received a submission from ECTEL containing the **ECTEL Regional Spectrum Management Plan** for its Member States.
2. A copy of the consultation on the draft ECTEL Regional Spectrum Management Plan is available on the ECTEL website (www.ectel.int) and the Commission websites. Copies will be made available upon request from the National Telecommunications Regulatory Commission.
3. The initial comments period was set for **Monday 12th July 2021 to Friday 6th August 2021**, and was extended to **Friday 13th August, 2021**.

 - ix. Dynamic Spectrum Alliance Limited (DSA) - USA
 - 6 GHz License Exempt
5. The period for reply comments (Comment on Comments) period will now run from **Wednesday 18th August 2021 to Friday 27th August 2021**.
6. Following the reply Comments period, ECTEL’s Directorate will revise and submit therevised ECTEL Regional Spectrum Management Plan to the Council of Ministers for its recommendation and for adoption in the ECTEL Member States.
